Ensuring pathogens do not enter your farm is a 24/7 responsibility. It is important to be vigilant at all times and have measures in place to stop disease entering your farm or site. For example, pathogens can enter by: people (e.g. staff, visitors, collection or delivery lorries and drivers) or via wild birds, other wildlife or vermin.
