## How Livetec's Contingency Planning and support **saved farmer James Baxter over £45,000**

# Avian influenza outbreaks are at the highest level since records began, and the threat of being impacted by an outbreak is increasing.

Livetec Systems has worked closely with James Baxter, owner of Glenhead Farm, Chairman of the British Free Range Egg Producers Association and board member for the British Egg Industry Council, since 2019. When Baxters' poultry farm was impacted by avian influenza (AI), Livetec's Contingency Plan was instantly used to provide all the essential documentation needed for the Animal and Plant Health Agency (APHA). Having the paperwork ready meant that APHA were able to conduct testing very quickly preventing a further loss of £45,000 to the business.

## **The Challenge**

Based in Scotland, James Baxter owns one farm, home to a large number of laying hens housed in 12 sheds.

This future-forward, unique farm runs an efficient 'circular economy'. The farm uses wind turbines for energy, wood chip boilers to heat, ventilate and light the sheds, as well as a combined heat and power plant.

The farm is situated on a peninsular and is in an isolated spot away from other farms. At the time of the outbreak there were no Surveillance Zones or Protection Zones in place nearby.

A forward-thinking individual, James had already made sure that his business and farm were insured, and had made the necessary preparations, with effective contingency planning, should the worst happen.

Despite maintaining strict biosecurity, and operating an incredibly eco-friendly operation, on the 26th January, James suspected that one of his hen sheds may be affected.

# **The Decision**

## **The Result**

James Baxter recognises there will always be mortality in sheds with odd spikes where you might get four in a day. However, on Thursday 26th January 2023, in the afternoon, there were roughly 60 dead hens in the shed and other hens looking sick. He suspected they were infected with avian influenza and immediately contacted APHA and his own vet.

He used the Emergency Response Plan that Livetec had prepared. The plan included all the necessary information to move the process for notifying a suspected disease along swiftly (rather than just process).

APHA had arrived. Since Baxter had all the documents prepared in advance with the Livetec Contingency Plan, it only took half an hour for APHA to review the information and discuss the next steps. By 11:30 am, APHA was ready to take samples from the farm. "They spent the next couple of hours in the shed, gathering up a few samples", James recalled. Once they collected the samples, they were sent to Weybridge for further examination. By this point, 70 hens had died. The vet confirmed Baxters' suspicions and said. "Look, I'm pretty sure it's AI. I'll be back first thing in the morning to count the chickens to calculate how many hens are dead."

The vet came back on Saturday morning (28th January 2023), to discover the mortality rate has increased and 512 hens out of 192,000 had died. Baxter paid the costs for the 512 hens, but if the vet visited on Sunday, Baxter would have had to cover the expense of 5,000 dead hens.

Not only was James able to save £45,000 by reacting quickly, the Contingency Plan rapidly sped up the process of depopulation and allowed him to receive compensation quickly.
